It's Time to End Child Abuse

April is Child Abuse Prevention Month

Every April, we take a break from our busy lives to think about children suffering from abuse. We might wear a blue ribbon. Or attend a local event stressing the need to support abused children. But with more than 874 confirmed child abuse and neglect victims in Peoria County alone, we need to do more. We MUST do more.

Abused children who do not get the help they need to heal are more likely to grow up to be abusers themselves. They are also more prone to suffer from mental health issues, drop out of school, end up homeless, have children before they are ready, turn to crime and strain our already fragile social safety net. This downward spiral not only threatens the future of the child, but that of our community. There are far too many children in the overburdened foster care system.



We all have the opportunity to positively impact the future of a child when we get involved with CASA (Court Appointed Special Advocates). We challenge you to stand with us and demand an end to child abuse and neglect. If we all come together, maybe one day—and hopefully very soon—we won't need a Child Abuse Prevention Month.

Why did you decide to become an advocate?


I became aware of CASA from my supervisor at Caterpillar. I initially became involved through the Sponsor a Child campaign, contributing a monthly donation to support a child being helped through CASA. As I became more aware of CASA's mission, I wanted to get more deeply involved. I was raised in a big family and knew how lucky I was to have wonderful parents and siblings. Through CASA training, I realized that there were many children in our community (800+) which were living lives of turmoil and despair. They needed someone like me for a friend – someone not to judge or discipline – just care.

Do you have any advice for other volunteers?

As a CASA volunteer, never forget the impact that you can have on the lives of your CASA kids. I never realized how much my friendship meant to one of my little guys until I missed a month of visiting and he said to me, "It's been five weeks since you were here." You are a friend. You are someone who they can count on. As their case workers, counselors, doctors, teachers or even their home changes over time, you are the one who remains the same. Never underestimate how important this is!

What has been one of your most memorable moments as a CASA Volunteer?

I've definitely had many memorable moments being a CASA volunteer. One that was especially poignant was when a court date was approaching. My little CASA girl



What are your challenges as a CASA?

I think one of my challenges is the emotions that go along with being a CASA. Upon arriving at the foster home, you feel sheer joy when a child runs to the door to greet you. During the visit, you find out that the children's Mom, who has been working hard to regain custody of her children, has fallen back in her progress and they now realize returning home to her will be delayed once again. It's in times like these I remember how important my role is to the children. And when the visit ends, they bring joy once more giving me a hug and waving as I drive away.

Is there anything else you would like to share?

Never miss an opportunity to invite your family members, friends or co-workers to step up and be the Voice for a Child. There is nothing more satisfying or fulfilling.

If you are considering making a gift by bequest, please meet with your attorney to discuss the ramifications and, if appropriate, to update your will. Additionally, please let us know if you have included CASA of Peoria County in your estate planning.

The mission of CASA of Peoria County is to advocate for abused and neglected children in Peoria County though the services of specially trained community volunteers.

DID YOU KNOW?

The CASA of Peoria County "Impact" Story

CASA of Peoria County is not state funded and relies on individual donations, corporate sponsorships, and grants to implement our direct services. The average cost per child placed outside of the family home costs taxpayers approximately \$5,700 per month. CASA involvement reduces the time children spend in foster care by an average of 8 months. A case with a CASA volunteer provides a potential savings to taxpayers of \$45,591 (8 months of foster care) per closed case.

Our 2017 goals include raising \$50,000 by May to recruit, train, and supervise additional volunteers and raise awareness of CASA of Peoria County's mission and purpose. When we meet that goal, we'll be able to serve an additional 41 abused and neglected children in Peoria County.
